## Research Activity

In my doctoral thesis, I analyse the role of public accountability in fostering the relations between state institutions and market actors. Using a quasi-experimental approach across multiple spatial and temporal settings, I observe how accountability and limits to power can pave the way to economic growth through an improved interaction of the public and private sectors. In contrast, the deterioration of these institutions is associated with patronage or self-interested behaviour.

Besides the specificities of each paper, my research brings a unified contribution to the economic literature. Even if checks and balances as well as transparent practices in public administration tend to be viewed more as values of political or legal philosophy than on the grounds of economic relevance, they are shown to have direct implications on economic outcomes. In fact, they make the public sector more predictable and credible in the eyes of private actors, thereby facilitating the cooperation of the two. In addition, they slim the chances for discretion and its distortionary effects.

I study the possibility of patronage associated to discretion in hiring. To this purpose, I exploit the exogenous change of the electoral timing in a quasi-random group of Italian regions that were scheduled to vote during the spring of 2020. Focusing on the job contracts awarded without public competition, I find that the probability that new public employees come from the same region as the hiring office falls right after the elections are postponed, but surges by a similar magnitude as soon as the updated election date is announced.

I compare the two colonial regimes defined by the British in Central India. In the long run, institutional settings that enforced standardised practices in the public administration have produced a higher average economic development than those of protectorates where the rulers' discretionary power faced smaller limits. The former structures improved the coordination with the private sector, which made infrastructural investments possible. However, this has also resulted in higher inequality.

The papers mentioned above have been presented in conferences and seminars across different departments and research units, of which I mention: Sciences Po Paris (April 2023), University of Milan (May 2023), Queen Mary University of London (May 2023), Free University of Bolzano (March 2024), ETH Zurich (June 2024), University of Bolzano (April 2025). I have been contributing to the academic profession by refereeing papers in peer-reviewed journals, including the European Economic Review and the Journal of the European Economic Association.

## Experience \_\_\_\_\_

#### University of Bologna, Research Fellow

Among other activities, I have defined a research project concerning an Indian state ruled by four consecutive queens at the time of British colonisation. This is a unique characteristic, which came with the promotion of proto-feminist ideas by those queens. Thus, I observe whether there is an institutional origin of female empowerment. I proxy the latter by some measures of within-couple bargaining power surveyed at current times. Applying a spatial RDD along the border with other native states that were traditionally ruled by men, it seems that – among others – women from the treated group have a higher age at first union, and a better match between the actual and desired number of children.

#### **School of Transnational Governance, EUI**, Research Assitant (part-time)

I have produced a descriptive analysis of the relation of trust in political and non-political actors, as well as their associated socio-economic factors, across the EU at the regional level. I have also used cluster analysis to define five groups of regions with similar characteristics of trust in institutions.

#### University of Bolzano, Research Fellow

I have analysed the effects of the emergence of political dynasties on public spending and public good provision in a developing country. The issue has been addressed with unique district-level data from Indonesia, and with particular interest to the following trade-off. Are dynastic politicians in quest for personal enrichment and power accumulation through public policy? Or are they more expert in the field, hence capable of delivering more efficient administration? Although the first component does not seem dominant in the short term, the deterioration of public policy outcomes becomes clearer as more time elapses from the election of a dynastic ruler.

I have been a teaching assistant in the master's course of International Finance, which dealt with macroeconomics in open economies. My tasks included holding weekly exercise classes and office hours, as well as grading biweekly assignments.
